- ✚ **Additions to the agenda:** Change Creston to Greenfield on the agenda and add by-laws. PJ West motioned to change the agenda, Vicki Hodge seconded, motion carried
- ✚ **Approval of minutes:** Tracey Mavis motioned to approve the minutes, PJ West seconded, motion carried.
- ✚ **PCA update:** Discussion was made about doing the Open Table night – with presenting materials and/or serving dinner. Contact Jane Willan about more information. Other ideas presented: farmers market and Family Rewards (3 County area)
- ✚ **Website Update:** Victoria discussed what to look forward to on the new website www.iowacommunitypartners.org which will be up and running by the end of the month.
- ✚ **Decat and Contract updates:** Lisa discussed information from the Governance Board meeting – Decat, Family Team Meeting facilitation, Family Assistance, Restorative Justice, Crisis Care budgets are reduced due to funding.
- ✚ **CBCAP update:** Great Beginnings classes have started and going well. Facilitators are trained. \$1000 that was budgeted toward crisis care is being redirected to PCA funding or the Great Beginnings classes.
- ✚ **Update on Upcoming Conferences:** Multi-County Conference – 110 registered to attend
- ✚ **3 County Risk Factor Assessment:** PJ West reviewed the 3-County Risk Assessment to members that were not present at the last meeting. Every program will be required to use the toolkit but not all of it. Tracey Mavis will bring more information on Life Skills Progression at the next meeting.
- ✚ **Additions to the agenda- By-laws:** In the By-laws it is stated that if a Board member misses 3 consecutive meetings the Decat coordinator will contact the member to discuss their continued role on the SDMT. If the member does not wish to continue a replacement will be sought. Lisa will contact Heidi Bloomquist, Melissa Wynn, and Steve Callison. - ✚ **Information Sharing:** Jody D shared the State Empowerment Board will be in Union/Adair county May 15th and 16th. Vicki H. that the RICC will be moving into the shelter. Tracey M. stated that enrollment for Head-start has been really good and Family rewards program has 22 members in Adair County. PJ West shared that FaDDS is struggling with capacity.
